



Shared Vision and Ambition

The Asian Development Bank (ADB) and the Agence Française de Développement (AFD) Group have cofinanced over 70 projects amounting to \$¹13.8 billion. Since our first cofinancing initiative in Viet Nam in 1997, we have grounded our partnership on our shared vision of development that allows us to set greater ambitions.

In 2003, we formalized our partnership with a Memorandum of Understanding that reflected our common desire to achieve concrete results. In 2010, our partnership reached new heights with our first three-year Partnership Framework Agreement (PFA) for 2010-2013, followed by a Framework Cofinancing Agreement for 2013-2016. In 2016, we renewed our commitment to a stronger partnership with a new PFA for 2016-2022, where we targeted a more ambitious cofinancing of \$1.5 billion each for the next 3 years. We included tangible collaboration objectives on some major themes: urban transport, sustainable cities, climate change, air pollution, and social protection. In February 2019, we amended the PFA to adopt higher cofinancing targets of \$2.5 billion each for 2019-2022. Since 2010 to date, ADB and AFD have achieved \$7.9 billion and \$3.4 billion in project financing, respectively.

Beyond project cofinancing, we

- discuss respective strategies and collaboration opportunities at annual high-level meetings
- manage several regional facilities to finance project feasibility studies with a view to future cofinancing, e.g., Cities Development Initiative for Asia, ASEAN Catalytic Green Finance Facility
- engage in personnel exchanges through secondment arrangements
