## AGENCE FRANÇAISE DE DÉVELOPPEMENT EURO 70,000,000,000 Euro Medium Term Note Programme

This supplement (the "**Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 15 December 2023 granted approval no. 23-516 on 15 December 2023 by the *Autorité des marchés financiers* (the "**AMF**") (the "**Base Prospectus**") as supplemented by a first supplement thereto dated 6 May 2024 granted approval no. 24-141 by the AMF and by a second supplement thereto dated 6 June 2024 granted approval no. 24-198 by the AMF, prepared in relation to the €70,000,000,000 Euro Medium Term Note Programme of Agence Française de Développement (the "**Issuer**"). Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Supplement.

The Base Prospectus as supplemented constitutes a base prospectus for the purposes of Article 8 of Regulation (EU) 2017/1129 of the European Parliament and of the European Council of 14 June 2017 (the "**Prospectus Regulation**"). This Supplement has been prepared in accordance with Article 23 of the Prospectus Regulation. Application has been made for approval of this Supplement to the AMF in its capacity as competent authority under the Prospectus Regulation.

This Supplement has been prepared for the purposes of (i) incorporating by reference the half-year financial report of the Issuer for the period ended 30 June 2024 (the "2024 Half-Year Financial Report"), which contains *inter alia* the Issuer's 2024 consolidated half year accounts (including the auditors' limited review report thereon and notes thereto), (ii) updating the General Information on the Issuer section and (iii) updating the General Information section of the Base Prospectus.

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or material inaccuracy relating to the information included in the Base Prospectus which is material in the context of the Programme since the publication of the Base Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.
