This third supplement (the "**Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 16 December 2022 granted approval no. 22-490 on 16 December 2022 by the *Autorité des marchés financiers* (the "**AMF**") (the "**Base Prospectus**") as supplemented by a first supplement thereto dated 28 April 2023 granted approval no. 23-138 by the AMF and by a second supplement thereto dated 15 May 2023 granted approval no. 23-160 by the AMF, prepared in relation to the €60,000,000,000 Euro Medium Term Note Programme of Agence Française de Développement (the "**Issuer**"). Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Supplement.

The Base Prospectus as supplemented constitutes a base prospectus for the purposes of Article 8 of Regulation (EU) 2017/1129 of the European Parliament and of the European Council of 14 June 2017 (the "**Prospectus Regulation**"). This Supplement has been prepared in accordance with Article 23 of the Prospectus Regulation. Application has been made for approval of this Supplement to the AMF in its capacity as competent authority under the Prospectus Regulation.

This Supplement has been prepared for the purposes of (i) incorporating by reference the half-year financial report of the Issuer for the period ended 30 June 2023 (the "**2023 Half-Year Financial Report**"), which contains *inter alia* the Issuer's 2023 consolidated half year accounts (including the auditors' limited review report thereon and notes thereto), (ii) updating the General Information on the Issuer section and (iii) updating the General Information section.

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to the information included in the Base Prospectus which is material in the context of the Programme since the publication of the Base Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

BDO and KPMG S.A. are registered as *Commissaires aux Comptes* (members of the *Compagnie Nationale des Commissaires aux Comptes*)."
